cerns around security of user data on the platform.

WhatsApp emphasised that it does not share users' contact lists or data of groups with Facebook for ads purposes, and that neither WhatsApp nor Facebook can read messages or hear calls between users on WhatsApp.

Last week, WhatsApp had informed users of an update in its Terms of Service and privacy policy regarding how it processes user data and partners with Facebook to offer integrations across the social media giant's products. It also stated that users will have to agree to the new terms and policy by February 8, 2021, in order to continue using WhatsApp's service.

This kickstarted a spate of conversations and memes on the internet over WhatsApp's alleged sharing of user information with Facebook, and many users have started shifting to Telegram and Signal. "We want to be clear that the policy update does not affect the privacy of your messages with friends or family in any way. Instead, this update includes changes related to messaging a business on WhatsApp, which is optional, and provides further transparency about how we collect and use data," WhatsApp said.

It added that WhatsApp accesses only the phone numbers from the address book to make messaging fast and reliable, and that it doesn't share contact lists with the other apps Facebook offers.
